

**ADDENDUM No. 1
for

This document serves as Addendum No.1 for the Invitation for Bid (IFB) for Floor Tile Replacement at Williams Middle School. This Addendum forms part of the IFB and modifies the original document. **Acknowledge the receipt of all addenda numbers issued on the BID SUBMISSION FORM.** Failure to do so may subject the bidder to disqualification.

The following changes and/or additions are to be made to the original Invitation for Bid dated May 30, 2012:

CHANGES TO SECTION: SW- Scope of Work

1. Add the following to the ‘General Specifications’ section:

“In locations where vinyl baseboard is present and removed by the abatement contractor (along built in furniture and counters, etc, in Rooms: 2,3,19,20,21), the floor tile replacement contractor will reinstall beige vinyl baseboard once the flooring installation has been completed.

CHANGES TO SECTION: SW, ALTERNATE NO. 2, THE ‘TEACHER’S LOUNGE’:

Delete the Scope of Work provided in the original IFB document for Alternate No.2, and in its place insert the following text:

“All tile and all carpet, floor transition molding and floor mastic adhesive within the teacher’s lounge will be removed and legally disposed of by the abatement contractor.

The Town will remove the Pepsi beverage machine and the L-shaped counter sectional located in the area that is currently carpeted. The Town will handle the move and reinstallation of these items once all flooring services have been completed.

The Contractor shall install new VCT floor tile per Scope of Work, General Specifications and Technical Specifications in the entire Teacher’s Lounge.”

CHANGES TO SECTION: SW, ALTERNATE NO. 3:

The original IFB document refers to Alternate No.3 as being Room No. 16 in both the Scope of Work and Drawing List. Delete all reference to ‘Room 16’ within the original IFB document, and in its place insert ‘Room 15’. The actual location of the room to be serviced under Alternate No.3 is Room 15, which is the Alternate No. 3 room that was toured during the mandatory pre-bid conference.
