Clarification on Items:

- A. The Audio-Visual Package will need to have the ability to broadcast, record and archive, and stream via the internet.
- B. For overflow purposes from the multipurpose room, only the large conference room will be used. The small conference room will not be used for overflow from the multipurpose room.
- C. For IPad and tablet interfacing and connectivity, the number of users will be ten (10). Multiple proposal options for this function are encouraged.
- D. For set up and control of the audio-visual system, the ability to remotely (off site) do so is desired.
- E. Two (2) points of control are required for the multipurpose room. The first being at the back left of the room where the audio-visual controller will potentially be stationed. The second is at the front left of the room at the desk where the Clerk to the Board will be seated.
- F. The phone system that will be installed in the building will be digital, standardized ESI, with VoIP capabilities.
- G. The IT switch will be Cisco, and the Owner will provide that.
- H. For WIFI security, access will be via USB port.
- I. The vendor will need to include a resident PC for access in their proposal.
- J. The conference table used in the large conference room will be 54 inches wide by 18 feet long. It will seat 18 people and likely have a raised data port/power port section in the middle of the table.
- K. Omit references to attachment II (Project Cost Summary Sheet) or attachment III a
 j (Individual Room Cost).
