You are hereby notified of the following changes, deletions, additions, and clarifications to the RFP.

Questions and Answers

1. **Question:** I have recently received a copy of your RFP for Update the Water Master Plan. I wanted to see if this solicitation is open

Answer: *The Sewer Masterplan is available on line. Visit the City's website at www.lynwood.ca.us, click on "City Services", then select "Bids and RFPs". It will give you instruction for a link to the City's Sewer System Management Plan.*

2. **Question:** The RFP discusses RDII evaluation. Is the City expecting Wet Weather Flow Monitoring as part of this effort?

Answer: *No - but we have drainage problems during rains in certain areas of the City that need to be evaluated.*

3. **Question:** Is the City expecting new CCTV inspection to be performed for this effort? Or will existing CCTV data be used for prioritization? How much existing CCTV data is available for review?

Answer: *Both, we are using existing CCTV data and in severe areas we will re-camera to establish priority*

4. **Question:** Which of the CIP projects included in the 2009 Capacity Assessment have been implemented?

Answer: *Identifying and prioritizing current infrastructure deficiencies for upcoming CIP*

5. **Question:** Under proposal submittal requirements in the RFP, what is the difference between project experience and references? Are three separate projects required for each?

Answer: *You may use the same Project contacts under the References. We often call the references to ask follow up questions.*

6. **Question:** What is the budget estimate for accomplishment of this requested project?

Answer: *We have set aside \$150,000 for the Project. However, we understand that the final proposals received will determine the market price for this Project.*

7. **Question:** There are target dates of 2032, 2033, & 5-year and 20-year terms in the RFP. Please confirm if all four are correct as shown.

Answer: *Yes, that is correct*

8. **Question:** How many On-Site Waste Treatment Systems (septic) are in existence in the city?

Answer: *22 residential septic and commercial systems*

9. **Question:** How many lift stations are in the city sewer system?

Answer: *No lift stations - all gravity feed to LA sanitation*

10. **Question:** When was flow monitoring last conducted within the city sewer system?

Answer: *No flow monitoring conducted*

11. **Question:** When was CCTV inspection last conducted of the city sewer system? What was the reporting format for that inspection?

Answer: Majority is 2007 - we have established some new videos for new installation and repairs (Long Beach Blvd.). There are notebooks - but the majority of the notes are in the videos.

12. **Question:** Is the flow monitoring and CCTV data available for reference?

Answer: We have no flow monitoring - The CCTV is available

13. **Question:** Does the City have a current system model, and what model system is in use?

Answer: No
