

**CONTRACT AMENDMENT**

**TO**

**AGREEMENT FOR THE MANAGEMENT AND OPERATION OF A FIXED-ROUTE MUNICIPAL TRANSIT SERVICE**

**WHEREAS**, the City of Lynwood, hereinafter called "CITY" and MV Transportation, Inc. hereinafter called "CONTRACTOR", have entered into an Agreement dated September 17, 2013, which Agreement sets forth the terms and conditions for the operation of the CITY'S fixed route transportation services on designated routes within Lynwood and adjacent areas; and

**WHEREAS**, on November 15, 2017, the Lynwood City Council adopted Resolution No. 2017.254 approving the revised revenue service hourly rates as proposed by CONTRACTOR for Year 5 of Agreement.

**NOW, THEREFORE in consideration of mutual covenants and agreements hereinafter contained, the parties hereto do hereby agree as follows:**

1. That Section VIII. Compensation is amended to revise the hourly rates for Year 5 as follows:

Year 5	Revenue Service Hour Rate (CNG Bus)	Revenue Service Hour Rate (CNG Trolley)
From:	\$ 56.12	\$ 54.79
To:	\$ 59.41	\$ 57.97

2. All other terms and conditions of said Agreement dated September 17, 2013 shall remain unchanged.

IN WITNESS WHEREOF, the CITY and CONTRACTOR hereto have caused this Amendment to Agreement to be duly executed with all the formalities required by the law on the respective dates set forth opposite their signatures.
