

#### LEGAL REQUIREMENTS

Respondents are required to comply with all provisions of Federal, State and County laws and Ordinances, rules and regulations, that are applicable to the items being requested. Lack of knowledge by the respondent shall in no way be a cause for relief from responsibility, or constitute a cognizable defense against the legal effect thereof.

#### PUBLIC ENTITY CRIMES

The County reserves the right to inspect all facilities of firms in order to make a determination as to the forgoing. Jackson County reserves the right to waive any irregularities and technicalities and may, at its discretion, request re-advertise this RFP.

#### ALTERNATIVES/APPROVED EQUAL DEVIATIONS

Unless otherwise specified, the mention of the particular manufacture's brand name or number in the specifications does not imply that this particular product is the only one that will be considered for purchase. This reference is intended solely to designate the type or quality of merchandise that will be acceptable. Alternate offers will be considered and must include descriptive literature and/or specifications. Failure to provide descriptive literature and/or specifications with alternate offers may be cause for disqualification of the response. The determination as to whether any alternate product or service is or is not equal shall be made by Jackson County and such determination shall be final and binding upon all responses.

The respondent shall be responsible for reading very carefully, and understanding completely, the requirements and the specifications of the items requested. Any deviation from specifications listed herein must be clearly indicated, otherwise it will be considered that items offered are in strict compliance with these specifications, and the successful respondent will be held responsible therefore; deviations must be explained in detail on an attached sheet(s) and itemized by number. Any item or items that do not meet County specifications upon delivery will not be accepted and if the item cannot be brought up to specifications in a reasonable time, the firm will be required to compensate the County for difference in price entailed in going to the next low firm.

The Jackson County Tourist Development Council (TDC), also known as Visit Jackson County, is seeking qualified proposals for the design, publication, and printing of a new Visitors Guide. The Jackson County TDC is the Destination Marketing Organization for Jackson County, Florida and seeks to improve the local economy by promoting, marketing, and supporting recreation and tourism to Jackson County. We strive to promote sustainable nature-based tourism options, while also shining light on our other assets in the historical, cultural, and agricultural fields.

Jackson County TDC seeks the following:

- 1. An attractive, inviting update to our current Visitors Guide
- 2. A digital version of the completed guide to be published on the Visit Jackson County website. \*Note: We are also planning a website update and wish to have complimentary content available on both platforms.

As an entity of the Jackson County Board of County Commissioners, we seek to provide an unbiased opinion of our area and the businesses that compose the tourism scene in Jackson County. This publication will be funded by grant dollars, so no advertising within the Visitor Guide will be allowed.

# BUDGET

Our maximum budget is \$25,000, which includes an allocation for the printing and delivery of 20,000 completed Visitor Guides.

# TARGET AUDIENCE

The visitor profile of tourists to Jackson County is quite varied. Historically, "baby boomers" made up our primary segment of visitors. Over the years, our visitors have changed slightly due to new trends in tourism. Now, we see a healthy amount of millennials mixed in the baby boomers and also welcome families of all ages and sizes throughout the year.

Due to our proximity to the coast communities of northwest Florida, we tend to see a fair amount of day trippers looking for something different to do. Our drive market extends west to Texas and north into the Carolinas, sometimes beyond in the colder months.

# **KEY FACTORS TO INCLUDE:**

- Things to Do
  - Water Based Activities: springs, paddling, diving, fishing, skiing, wakeboarding, tubing, snorkeling, swimming, etc.
  - Outdoors: Hiking, biking, birding, spelunking, hunting, horseback riding, camping, wildflower viewing, golfing, stargazing
  - History: Historic Districts, Homes, Sites; Spanish Heritage Trail, Historic Markers, Battle of Marianna, Highway 90 and the Old Spanish Trail, etc.
  - Culture: Agri-tourism and ag heritage, arts, music, theatre, live performances, etc.
- Community: Lodging (vacation rentals, campgrounds, hotels, and motels), restaurants, shopping, day trips
- Events: Annual events and event venues (sports, meetings, weddings, family reunions)
- Maps: County map and how to get here from familiar destinations

# **CURRENT GUIDE**

Our current Visitors Guide is well over 5 years old and features plenty of information about Jackson County. This information could use some updating and has not been segmented into defined sections in the past, something we would really like to see changed. The guide is currently 48 pages long, self-cover, saddle-stitched; measures 8<sup>3</sup>/<sub>8</sub>" x 10<sup>7</sup>/<sub>8</sub>" portrait orientation; 4 color process; printed on 60 lb. gloss text.

# NEW VISITOR GUIDE REQUIREMENTS

- 52 pages featuring a 4 page cover and 48 page body. We will also entertain quotes for a 62 page guide, 4 page cover and 58 page body.
- Portrait orientation with same size dimensions as current guide, possibly a little larger. We do not wish to publish a smaller guide at this time.

- 3 pages dedicated to maps: 2 pages will represent Jackson County and a portion of the surrounding areas and 1 page will be in reference of how to get here from known destinations or our location in relation to the state of Florida or the Southeast United States.
- Waterways and boat landing guide for all nine (9) bodies of water with public access.
- Content needs to be updated from current guide. All content will have to be approved by Jackson County TDC staff and respective city, county, state, and national organizations. This can be facilitated by Jackson County TDC staff or the chosen vendor.
- Photos will be provided from our new digital library. Additional photos may be necessary for some areas of the guide.
- Sections should be created to compliment new content on the Visit Jackson County website. This will be discussed in a conference style setting with the website vendor, the visitor guide vendor, Jackson County TDC staff, and up to one TDC board member.
- Jackson County TDC will provide bullet points and additional information for each section upon request. All copy is expected to be provided by the visitor guide vendor, unless otherwise specified. Any content expected to be provided by Jackson County TDC staff should be explicitly stated in the proposal.
- Within two (2) weeks of being selected, the vendor must provide preliminary design concepts for review and selection by Jackson County TDC staff and/or TDC board members.
- In addition to our identified target audiences, the following audiences will also be served by this visitor guide: locals (business and residential), travel planners, meeting and event organizers, local and regional press and media, potential businesses and industry looking to relocate to Jackson County, residents relocating or retiring to Jackson County, travelers passing through on their way to a different destination, and clientele of local businesses. The new visitor guide must remain unbiased, but attractive, informative, and user-friendly enough to reach all audiences.
- The chosen vendor should incorporate the Jackson County TDC/Visit Jackson County logo and branding throughout the guide, wherever applicable.
- We would like to see a semi-aqueous coating on the front and back cover and heavier stock paper throughout the guide. Quotes should reflect multiple options to meet these requests based on different budgetary allowances.

# QUALIFICATIONS

Vendors submitting a bid must include the following:

- Samples and reference work for previously completed and published destination visitor guides. If multiple editions are available, samples of each edition should be submitted as well.
- Costs for annual content and design updates, listed separately from cost of initial design and printing of the publication. Quotes should be available for each of the options regarding heavier paper and semi-aqueous coating for the front and back cover.
- Breakdown of costs throughout the project, including printing of 20,000 visitor guides. Delivery/shipping charges should also be included but listed separately from the cost of printing the guides unless otherwise specified.
- Project timeline including important project milestones and any deadlines to be met by Jackson County TDC staff.
- Description of how creative content (copy) will be obtained and what will be expected of Jackson County TDC staff to accomplish this. Identify any assets that will be required from Jackson County TDC.

- Explain your approach to customer service and identify the number of employees that will be contributing to the success of the project.
- Provide a statement of understanding that relays that at the conclusion of the project, all materials developed by the designer of the visitor guide will be the exclusive content of the Jackson County Tourist Development Council/Visit Jackson County.

- Potential design templates submitted to Jackson County TDC by February 27, 2019.
- Creative content to be submitted for approval by Jackson County TDC and other organizations by March 27, 2019.
- Final edits and approval must be completed by April 17, 2019.
- Files must be delivered to the printer by April 24, 2019.
- Jackson County TDC must receive 25% of the printed guides by May 8, 2019.
- Jackson County TDC to receive remainder of guides by May 29, 2019.


