Each BIDDER shall acknowledge receipt of all ADDENDA in the space provided in the BID FORM. The BID FORM and BID FORM BOND must be submitted loose. It is not necessary to submit these documents in the bound specification book. Each BIDDER will be responsible to assume himself that all ADDENDA have been received.

The OWNER reserves the right to reject any and all bids, and may waive any informalities or minor defects.

Information obtained from an officer, agent, or employee of the OWNER or any other person shall not affect the risks or obligations assumed by the CONTRACTOR or relieve the CONTRACTOR from fulfilling any of the conditions of the contract.

Each BID must be accompanied by a BID BOND payable to the OWNER for five percent (5%) of the total amount of the BID. A certified check may be used in lieu of a BID BOND. As soon as the BIDS have been evaluated and a recommendation of the award accepted, the OWNER will return the BONDS of all executed, the BONDS of the two remaining unsuccessful BIDDERS will be returned. 
